Sub: Guidelines for obtaining Photocopy of Theory Answer Books, Mark-slips and Verification/ Re-totalling of Marks...

Ref: 1) University Ordinance No. 01/2014 2) University Circular No. 57/2022

It is notified to all concerned that various applications under Right to Information Act for obtaining Photocopy of Answer-book alongwith Mark-slips or only Mark-slips of Answer-book are being received by the University. The photocopy of Answer Book or it's Mark-Slips are not provided under Right to Information Act-2005. The University has laid down the following guidelines for obtaining Photocopy of Answer-books alongwith Mark-slips or only Mark-slips, including Verification/ Re-totaling of marks.

- 1. A candidate, who desires to obtain Photocopy of Theory Answer book/(s) alongwith Mark-slips of Theory Answer-book/(s) of any subject, should submit an application alongwith prescribed fee of Rs.700/- (non-refundable) per answer-book/paper to their respective college within 7 days from declaration of their result.
- 2. A candidate, who desires to obtain Photocopy of Only Mark-slips of Theory Answer-book/(s) of any subject, should submit an application alongwith prescribed fee of Rs.100/- (non-refundable) per answer-book/paper to their respective college within 7 days from declaration of their result.
- 3. A candidate, who desires to apply for Verification/ Re-totalling of Marks of Theory Answer-book/(s) of any subject, should submit an application alongwith prescribed fee of Rs.700/- (non-refundable) per answer-book/paper to their respective college within 7 days from declaration of their result.
- 4. A candidate, who desires to apply for Verification/Re-totalling of Marks of Practical or Oral/Viva marks of any subject, should submit an application alongwith prescribed fee of Rs.700/- (non-refundable) per Subject to their respective college within 7 days from declaration of their result.
  - Application of the candidates will be accepted by the concerned college alongwith requisite fees upto requisite due date only. Three separate lists shall be prepared by the respective college; viz, a) List of candidate applied for Photocopy of Theory Answer book/(s) alongwith Mark-slips of Theory Answer-book/(s), b) List of candidate applied for Photocopy of only Mark-slips of Theory Answer-book/(s) and c) List of candidate applied for Verification/Re-totalling of marks in Theory/Practical marks.
- 6. "Pay Online Fees" option is available on University Website (www.muhs.ac.in). The college shall pay all the requisite fees through online only. The college shall submit all the applications alongwith prescribed fees within 10 working days from declaration of result to the University inperson through their college representative. Proforma of Covering letter (Annexure-A), Proforma of Lists (Annexure-B, C & D) and Proforma of Applications (Annexure-E & F) are attached alongwith this circular.
