Respected Sir,

With reference to the above subject the Govt. of Maharashtra has sanctioned additional 70 beds at Gramin Rugnalaya, Kalambani Tal.Khed, Dist.Ratnagiri. Already the Gramin Rugnalaya has 30 beds with addition of 70 beds, the strength of Gramin Rugnalaya will be 100 beds. It will be designated as Sub-District Hospital, Kalambani, Tal.Khed, Dist.Ratnagiri. The Govt. of Maharashtra sanctioned Rs.195.95 lakhs (1,32,82,000/- + 63.13 lakhs from D.P.D.C.) for the construction of 70 beds hospital. Also the Govt. Of Maharashtra has sanctioned 63 various posts for functioning of Sub-District Hospital Kalambani.

The Public Work Department, Chiplun assured they will complete the construction work by the end of August, 2008. The full-fledged Sub-District Hospital will be functioning by the end of Sept.2008. We will cater to the patitents in various faculties.

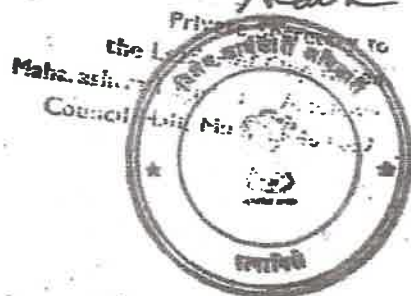
